### Faculty Position in Finance Deadline: December 1, 2016

The **Ivey Business School** invites applications from early or mid-career candidates to fill a Probationary (tenure-track) position at the rank of Assistant or Associate Professor. If qualifications and experience warrant, the appointment may be made with tenure at the rank of Associate Professor. A Limited Term appointment may also be considered; rank to be determined by qualifications and experience. The positions are available to begin in July 2017, although alternate starting dates may be arranged. Ivey prefers candidates working on behavioural finance, fintech, banking and financial intermediation, or corporate finance.

**ASSOCIATE PROFESSOR POSITION:** Applicants for a Probationary (tenure-track) or tenured appointment at the rank of Associate Professor will hold a PhD (or equivalent degree). The successful candidate will be an established finance scholar with a strong publication record in high quality finance outlets and a recognized expert in his or her field of research as demonstrated through a vigorous research program, external research funding, and invited talks/conferences. The ideal candidate would take a leadership role in fostering research at the school. Having links to the practice of finance through executive education, consulting experience and/or past work experience is also highly valued. Demonstrated ability to successfully teach in core undergraduate and/or MBA courses using a case discussion format is required.

**ASSISTANT PROFESSOR POSITION:** Applicants for a Probationary (tenure-track) appointment at the rank of Assistant Professor must hold or be nearing completion of a PhD (or equivalent degree). Candidates should have a strong academic background as demonstrated in the ability to publish in high quality finance outlets. The ability to teach in core undergraduate, MSc and/or MBA courses using a case discussion format is essential.

**LIMITED TERM POSITION:** Applicants for a Limited Term appointment are expected to be nearing completion of their PhD (or equivalent degree) with a strong research program and pipeline. The successful candidate will have demonstrated excellence in teaching in core undergraduate and/or MBA courses.
