Building on Our Strength

The past five years have been a period of building for the Asian Management Institute. As we draw towards our 5th anniversary, it is timely to take stock of what has been achieved and to plan for our longer-term strategy.

Case Development

With 290 cases at last count, Ivey is the top producer of current Asia-Pacific cases. This inventory of Asia-related cases represents about 14% of our total collection, versus 4% in 1997. More than 300 Ivey cases have been translated into Asian languages.

Publications

Since our major book publication project in 1998 – "A Total Solution for Management Education Material in China", the Ivey name has appeared on 63 Ivey edited books and case collections for the Asia-Pacific region. Train-the-Trainer Workshops

2002 marks the fifth year Tsinghua and Ivey offer the annual Case Teaching and Writing Workshop in Beijing. More than 200 teachers in China have received case method training provided by Ivey faculty. There are an estimated 2800 professors in China involved in MBA teaching. The number of MBA schools in China has risen from 56 in 1997 to 62 in 2001. Similar workshops also took place in Singapore, Hong Kong, and Shanghai.

The School of Economics and Management at Tsinghua University in Beijing, and the Nanyang Business School in Singapore are among a long list of our partners in the region. Increasingly Ivey is being sought after as a provider of teaching and learning material, executive training, case method training, and partners in case development and joint publications.
