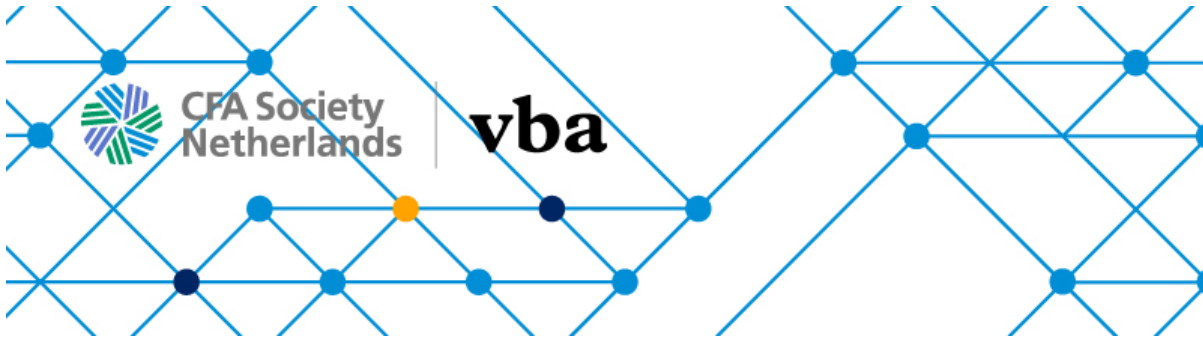

Blueprint for Investing in Alternatives under the new Pension Fund Regime in the Netherlands

We aim to start a working group within CFA Society VBA Netherlands to develop a blue print for the management of alternatives for pension funds in preparation for the new Dutch pension fund regime. The working group will focus on series of topics and publish working papers next to organizing round tables. Topics we are currently thinking to address are:



- Assessment of the impact of the change in regulations in light of the Pension Fund reform for investments in private equity, real estate and private credit and their impact on strategic asset allocation for pension funds;
- General requirements to enable ongoing management in respect of among others asset allocation (i.e. valuation- and liquidity management standards)
- International best practices in respect of alternatives in a DC regime and lessons learned;


